#### **Position Summary:**

The Nurse Practitioner Lead is responsible for coordinating and providing health care services to older adults and frail seniors as part of an interprofessional Geriatric Assessment Intervention Network (GAIN) Community Team. The Nurse Practitioner Lead will coordinate and work in collaboration with physicians, nurses and other health care professionals such as social worker, occupational therapist, pharmacist, and physiotherapist to offer geriatric clinical integrated care to support frail older adults and seniors to live well in their homes and community.

#### Responsibilities:

1. Provide Clinical Care and Consultation Services (Assessment, Diagnosis, Care Plan Implementation, Evaluation)

- Provide Care within the legislated requirement for a full NP Scope of Practice
- Conduct comprehensive geriatric assessment using GAIN model of assessment tools.
- Autonomously diagnose, order and interpret diagnostic tests, prescribe pharmacological agents, and perform specific procedures appropriate for geriatric clients within the legislated scope of practice

#### 2. Plan, Coordinate, Implement, Administer and Maintain client care in collaboration with internal and external providers

- Plan, promote and coordinate evidenced- based care for older adults and frail senior's with complex needs
- Coordinate and support GAIN team

#### 3. Ensures client safety and staff safety in all aspects of responsibilities

• Complies with the SPLC "Client Safety", "Risk Management" and "Health and Safety" policy statements and regulated requirements of affiliated professional association

#### 4. Establishes and promotes health and safety standards

- Provide recommendations to update policies, procedures and handbooks, communicates to trains clients and caregivers and monitors Infection
   Control procedures
- Ensures compliance with client safety responsibilities, internal policies, procedures and quality management
- Informs and instructs clients and caregivers regarding health and safety supervisory responsibilities and ensures that staff comply with health and safety legislation, regulations, and internal policies, procedures and quality management

- Two (2) years recent experience as a Nurse Practitioner in community/health care of older adults and seniors.
- Demonstrated extensive knowledge and skill working with individuals with various types of dementia, delirium, mental health, addictions,

responsive behaviours other neurological conditions, and those who experience an acute behavioural change

- Enhanced knowledge of family and caregiver needs who can be best-served by a behavioural support system
- Experience/ familiarity with RAI documentation including assessments, Resident Assessment Protocols (RAPS) and care planning functions
- Good physical and behavioural assessment skills for evaluating dementias, cognitive impairments, depressions, and deliriums, mental health and
   addictions

#### Others:
